RAMP EXTENSION INSTALLATION INSTRUCTIONS

Includes:

A) 2pcs - ALUMINUM RAMP EXTENSION

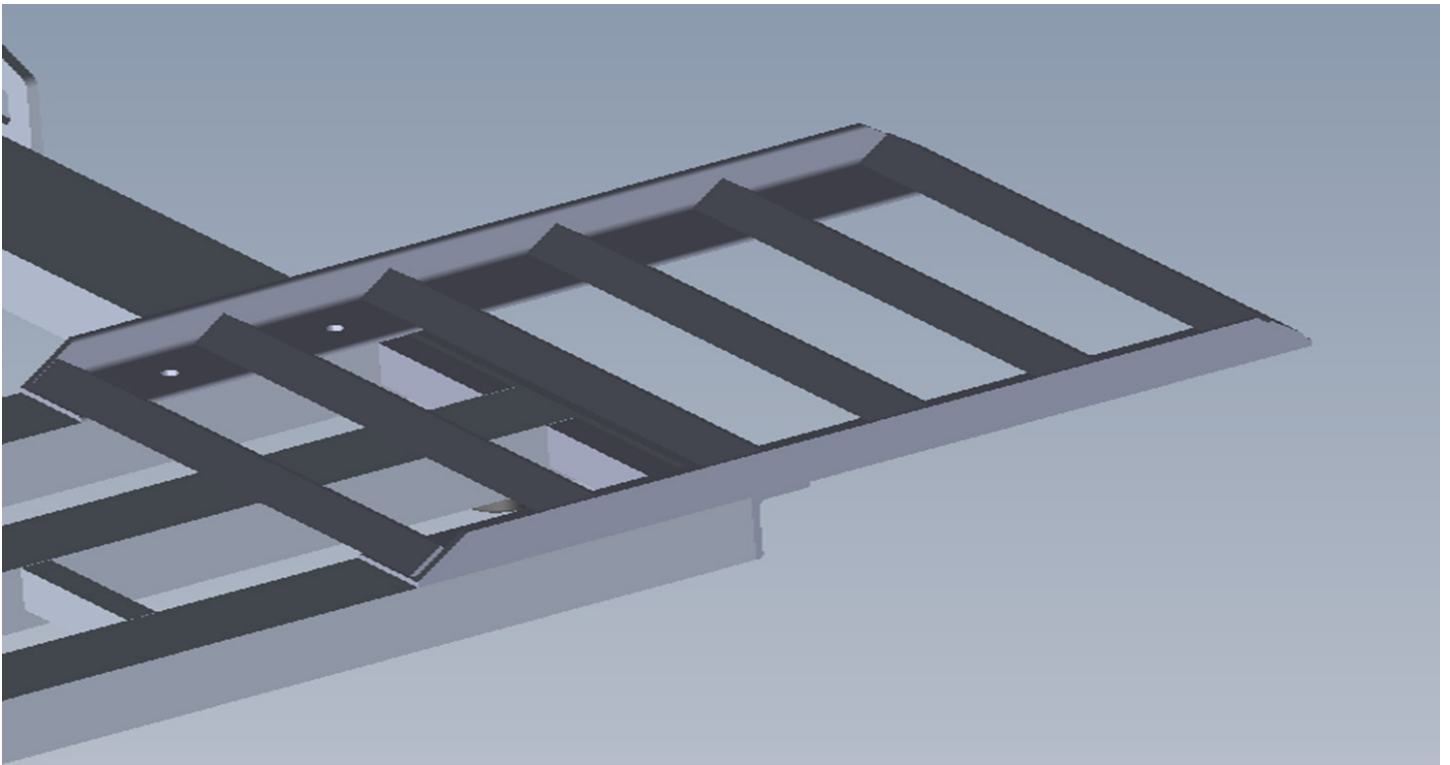
B) 8pcs - BOLT-1/2"-13 X 4.5"

C) 4pcs - BOLT-1/2"-13 X 3"

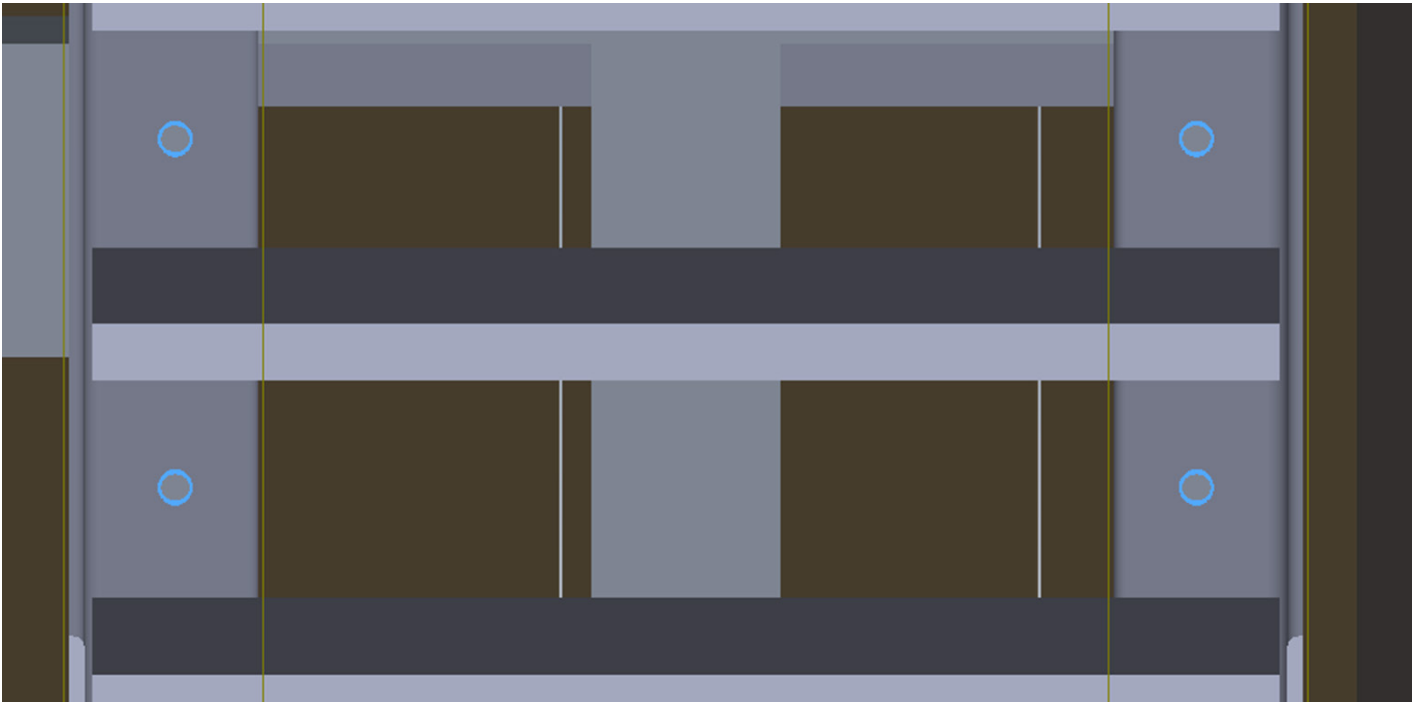
D) 24pcs - WASHER-1/2"

E) 12pcs - NUT-1/2"-13 NYLOCK

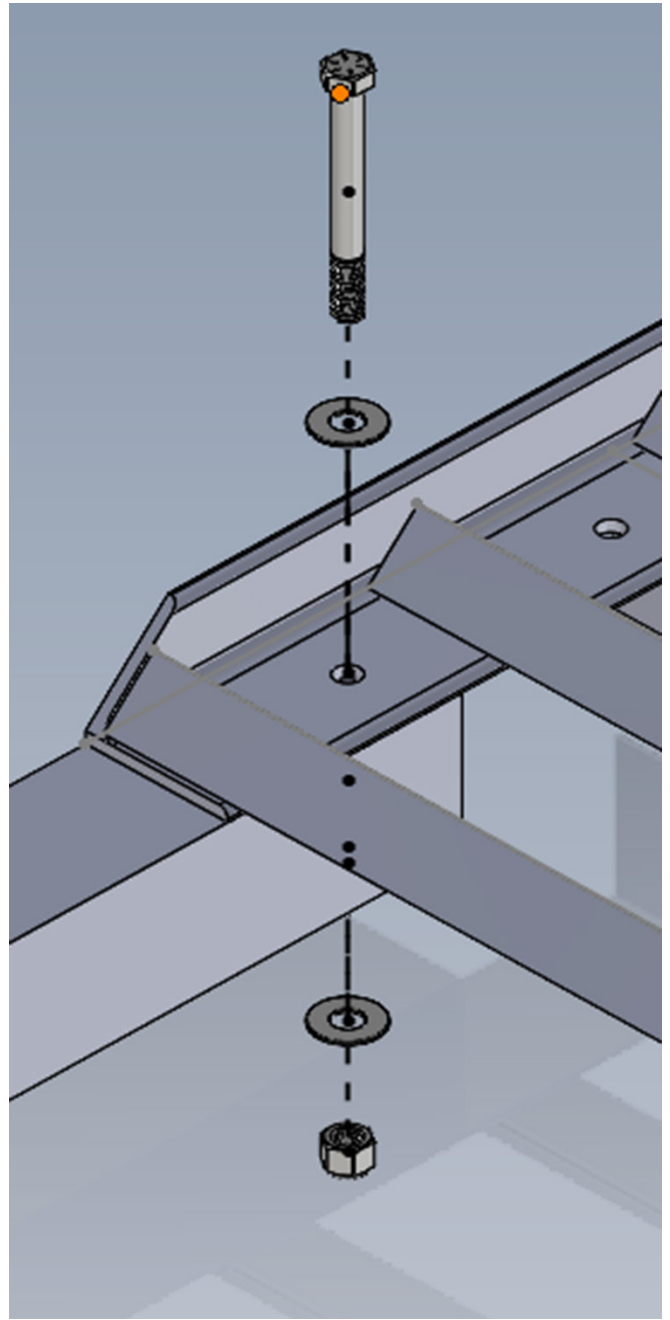
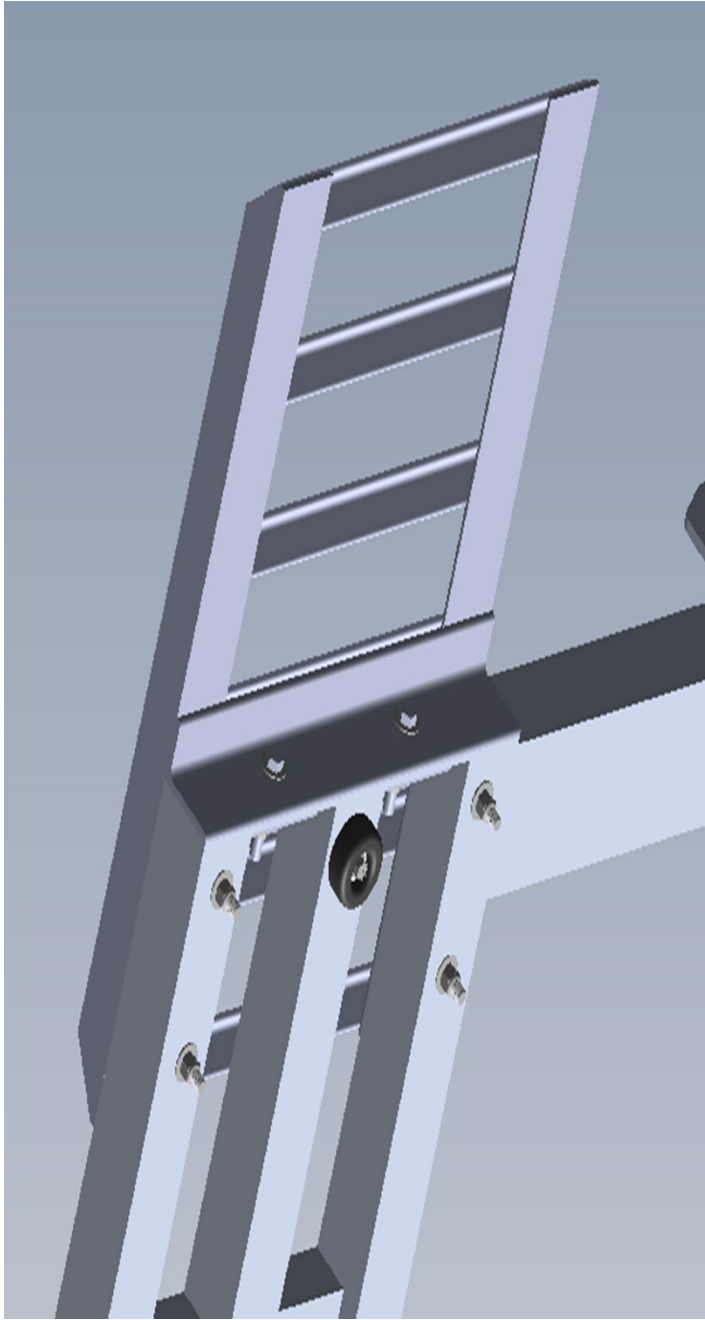
1. After removing both extensions and hardware from packaging, raise ramp up in the air slightly to ensure there is room to get around and under the ramp for installation. * NOTE: If ramp is not painted and is raw aluminum you will have to grind down the weld seam at the end of the ramp to ensure the extensions sit flush on the ramp. *
2. Now lay extensions (A) on end of ramp as seen below. Center the extensions on the ramp to ensure you drill in the correct spots in step 3.



3. At this point you can either mark the holes (12 total – see below) on the ramp or you can clamp the extension down to the ramp for hole location. There are 4 holes on the top of the extension and 2 holes on the back side of the extension as seen below.



4. Now drill your holes with a $\frac{1}{2}$ " drill bit. The top holes will take 1pcs BOLT (B), 2pcs WASHER (D), and 1pcs NUT (E) per hole (8 holes total). Then the backside of the extension will take 1pcs BOLT (C), 2pcs WASHER (D), 1pcs NUT (E) per hole (4 holes total). * NOTE: Drill and fasten rear two bolts before drilling top four holes. This ensures there is no gap between extension and ramp. *





TRAILER WARRANTY

EQ Outdoors Limited Warranty Policy August 2025

1. The structure of your EQ Outdoors trailer is warranted to the original retail purchaser against defects in materials and workmanship by EQ Outdoors, arising from normal use for (3) years from the date of purchase. The structure is that portion of the trailer which includes the main frame, consisting of the bottom rails, cross members, and the sub frame, excluding the floorboards (where applicable) and running gear.
2. EQ Outdoors warrants its powder coat finish to be consistent with industry standards for 90 days from the date of original retail purchase, with the exceptions of "normal use" limitations set forth below and of deterioration due to use or exposure, such as chipping, scratching, fading, cracks in caulk seams, road salt or tar, damage by animals or pressure washing. Warrantable paint repairs are limited to spot repairs and blending consistent with standards in the trailer industry.
3. Lumber is warranted for 90 days from the date of original retail purchase.
4. Tires, axles, brake components, springs and suspension components, couplers, batteries, solar panels, and lights purchased and installed by EQ Outdoors are warranted by their respective manufacturers and are excluded from this EQ Outdoors Limited Warranty.
5. This Limited Warranty covers only defects in original components which arise from normal use and does not apply if the trailer has been subjected to negligence, accident, abuse, misuse, neglect, overload or has been repaired or altered without the prior written consent of EQ Outdoors. Normal wear items, including but not limited to struts, lights, bearings, brakes, brake linings, tires and batteries will not be replaced due to wear.
6. Transportation of any trailer to and/or from your dealer or approved repair facility shall be the responsibility of the trailer owner. Travel expenses, hotel, telephone, fuel, or any other expenses of the like are not covered under warranty. EQ Outdoors shall not be liable for any such costs.
7. **THE SOLE RESPONSIBILITY OF EQ OUTDOORS UNDER THIS LIMITED WARRANTY SHALL BE TO REPAIR AND REPLACE PARTS AT EQ OUTDOORS FACTORY; HOWEVER, UNDER UNUSUAL CIRCUMSTANCES WITH PRIOR WRITTEN APPROVAL AND EQ OUTDOORS DISCRETION, A REASONABLE ALLOWANCE MAY BE MADE FOR REPAIR OFF SITE. ALL OTHER OBLIGATIONS OR LIABILITIES, INCLUDING INCIDENTAL OR CONSEQUENTIAL DAMAGES OR CONTINGENT LIABILITIES ARISING OUT OF THE FAILURE OF ANY PARTS TO OPERATE PROPERLY ARE HEREBY EXCLUDED, INCLUDING BUT NOT LIMITED TO ANY DAMAGES RESULTING FROM LOSS OF USE, INCONVENIENCE, LOSS OF TIME, COMMERCIAL LOSS OR ANY OTHER TYPE OF DAMAGES, GENERAL OR SPECIFIC, FORESEEN OR UNFORESEEN, UNLESS APPLICABLE STATE LAW PROVIDES OTHERWISE.**
